DEPUTIZED SERVICE IMPORTANT NOTE:

Whenever you have one or more defendants to be served outside Philadelphia (that is in another Pennsylvania county), you MUST MAKE OUT SEPARATE CHECKS - one check payable to B&R Services and one check payable to the Sheriff of the county in which the defendant is being served.

FEES FOR OTHER PENNSYLVANIA COUNTIES

Whenever you have defendants in another Pennsylvania county, B&R Services can forward to the Sheriff of the specific county in which service is to be made. The required base fee is \$35.00 for the first defendant and \$30.00 for each additional defendant to be served in any Pennsylvania County outside of Philadelphia. The cost for serving an additional defendant in Philadelphia is \$30.00 per address. There are no mileage charges for addresses outside of Philadelphia.

BUCKS COUNTY

\$58.00 forst defendant, \$21.00 each additional defendant.

CHESTER COUNTY

All civil actions require a deposit of \$200.00. Any overage will be refunded by the sheriff.

MONTGOMERY COUNTY

Writs, summons, complaints, etc., requiring service in Montgomery County \$58.00 For each additional defendant add \$41.00 Call these counties for their fees.
